# **Analysis and Observations:**

- A significant portion of students (44%) are achieving an A grade, indicating strong academic performance.
- A third (33%) is performing at a B level, showing that a substantial number of students are also doing well.
- A moderate portion (16%) of students receiving C's, are achieving average performance.
- A small group (8%) earns D's and F's.
- Notably, all students receiving a grade of D or lower have been provided with intervention forms to ensure they receive the necessary support and resources to improve their performance.
- Additionally, quarterly progress report grades have been provided to all sending schools, ensuring transparent communication regarding student performance.

This data provides a valuable overview of our students' academic performance as we move closer to the end of semester 1. Ongoing analysis will help us refine our teaching strategies and offer targeted support to ensure every student is set up for success as the semester progresses.
